2. Contractors who fulfill the following requirements shall be eligible to apply. Joint Ventures are not accepted. Foreign firms are not permitted to participate.
- a. Should have satisfactorily completed similar works of the following nature during the last five years ending last day of March 2010.

The similar work means: -

Irrigation work for Arboriculture and Landscaping

Or

Plumbing work for Township

OR

External water supply works

- b. Should have had average annual financial turn over of value stated in para 1 above during last three years ending **31st March, 2010**.
 - c. Should be profit making firm & should not have made losses during the last three years ending **31st March, 2010**.
3. Desirous contractors may obtain pre-qualification document in writing from the Director General, Married Accommodation Project, Kashmir House, Rajaji Marg, New Delhi -110 011 on payment of non refundable Demand Draft of Rs.500/- drawn in favour of Director General Married Accommodation Project and payable at New Delhi, on any working day **upto 06 Jul 2010 between 10.00AM to 4.00PM**.

The firms may download and take prints of the documents if they so desire and submit their completed applications as detailed in para 4 below along with cost of pre-qualification document stated above. Such applications (which have been downloaded from the website) received without Demand Draft for Rs.500/ will be considered non-bonafide and will be summararily rejected and returned back un-opened.

4. Application for pre-qualification supported by prescribed Annexures should be submitted in a sealed envelope duly subscribed with the name of work and due date of opening. **The applications will be received up to 14:30 hours on 09 Jul 2010.**

If any information furnished by the applicant is found incorrect and / or misleading and/ or false representation and/ or deliberately suppressed information, at a later stage, he shall be liable to be debarred from tendering/ taking up of any work for DG MAP project. The department reserves the right to verify the particulars furnished by the applicant independently.
6. The department reserves the right to physically verify the performance on works. The department also reserves the right to reject any prospective application without assigning any reason and to restrict the list of pre-qualified contractors to any number deemed fit by it.
