Subject: Use of Correct Grade and Designation by WES Officers

Reference: E-in-C's Branch, EIA Section's letter No. 90900/IDSE/Gp-2/39/EIA dated 29th May, 2014 on the captioned subject.

2. The matter was taken up with Department of Personnel & Training(DoP&T) and Department of Expenditure(DOE). DoP&T and DOE have clarified that non-functional up-gradation under NFU scheme is purely personal up-gradation to the officer and the same does not entail any right to use designation of higher posts on grant of NFU. Also, NFU need not necessarily entitle higher rates of Transport Allowance, as drawal of the Transport Allowance @ Rs. 7000/- p.m. is linked to eligibility of Staff Car under Staff Car rules and not merely drawal of Grade Pay of Rs. 70,000/- p.m. However, in case of Travelling Allowance(TA), Leave Travel Concession (LTC) and House Rent Allowance(HRA), NFU would entitle employees to higher rates/higher entitlement as these facilities are linked with the Basic Pay/Grade Pay of the officers.
